Introduction

Boards serve an important and often unrecognized service as they quietly protect the public. Board members possess unique technical expertise and function to assure a competent workforce in exercising this duty. Complex issues that surround complaint investigations, health policy, establishment of rules and regulations, and issuance of licenses are some examples of these important duties.

The mission of the Board of Psychology is to protect the public through enforcement of standards for licensure and ongoing clinical competence.

Board Composition

Licensing

Licensing of Psychologists by examination or by endorsement, represents one of the essential functions of RIDOH and the Board. Ensuring that Psychologists who are eligible to practice in Rhode Island are competent, ethical, and professional is critical to the licensing process.

From January 1 through December 31, 2020, the following Psychologist applications were processed:

Complaints and Disciplinary Actions

Health equity and justice extends to all areas of RIDOH. When a complaint is filed there is usually a desire, on the part of the complainant, to assign blame. RIDOH investigate complaints and strive to achieve consistent and just outcomes for all parties involved. If an investigation is opened, the Board needs to determine if a Psychologist must be held accountable or if the error/issue was more likely caused by systems issues beyond the control of the Psychologist. The Board strives to arrive at consistent decisions which protect the public and hold Psychologists accountable.

An essential role of the Board is to investigate and adjudicate complaints. Complaints come from a variety of sources, including patients, patient advocates, notices of litigation, licensed facilities, and other healthcare professionals.
