


**Joint Petition for Stay and Request for Acceptance of Consent Order**

**ORDER**

The Administrative Hearing Officer, after reviewing the Specification of Charges submitted by the Board and the Consent Agreement proposed by the parties pursuant to §14.0 of *The Rules and Regulations of the Department of Health Regarding Practices and Procedures before the Department of Health and Access to Public records of the Department of Health (R42-35-PP)* finds:


1. Respondent is a chiropractic physician in Rhode Island license number DCP 405;
2. Respondent admits to the jurisdiction of the Board and hereby agrees to remain under the jurisdiction of the Board;
3. Respondent after consulting with counsel voluntarily waives his right to appear personally or by counsel or both before the Board and/or the Administrative Hearing Officer; his right to produce witnesses and evidence in his behalf at a hearing; his right to cross examine witnesses; his right to have subpoenas issued by the Board and/or the Administrative Hearing Officer; his right to further procedural steps including his right to appeal the Consent Agreement and Order of the Administrative Hearing Officer to the Superior Court;

Further, the Administrative Hearing Officer hereby orders:

1. The Consent Agreement is accepted;
2. The Consent Agreement shall become part of the public record once it is accepted;

3. Respondent's License to practice Chiropractic Medicine in Rhode Island is suspended for the period beginning March 31, 2004 up to and including the date of signing of this Order.
4. Respondent will sign an Assessment and Monitoring Contract for a period of two (2) years with Affiliated Monitors, Inc. and will cooperate with each and every recommendation made by Affiliated Monitors, Inc. This contract <sup>will</sup> ~~with~~ include an audit and compliance plan *mak* that must be approved in advance by the Board. This audit and compliance plan will include documentation, billing and coding and treatment modalities.
5. Respondent in the future when ordering electro diagnostic testing will document that he has discussed with the patient the reason for the testing and the cost of the testing.
