

CONSENT AGREEMENT FOR VOLUNTARY SURRENDER

Pursuant to Section 5-31.1-11 of the General Laws of the State of Rhode Island, 1956, as Amended, the above captioned matter is before the Rhode Island Department of Health/Board of Examiners in Dentistry (hereinafter referred to as the "Board") charging Rashmi Vasudeva, DDS (hereinafter referred to as Respondent) with violation of Section 5-31.1-10 of the General Laws of the State of Rhode Island, 1956, as Amended.

After consideration by the Department, the following constitutes the findings of fact with respect to the professional performance of the Respondent:

1. The Respondent was issued RI dental license #DEN02826 on 19 August 2004;
2. The Respondent's RI dental license last expired on June 30, 2008 and remains non-renewed;
3. On or about 19 October 2010, the RI Board of Examiners in Dentistry received information that Rashmi Vasudeva, DDS, did voluntarily surrender her Massachusetts Dental License for a period of six 6 months for failing to provide services in compliance with the "Recommended Infection-Controlled Practices for Dentistry, 1993" published by the Center for Disease Control and Prevention ("CDC"), U.S. Department of Health and Human Services, Atlanta, Georgia;
4. The Commonwealth of Massachusetts Consent Order is incorporated and attached herewith;

Prior to a formal administrative hearing, the following is agreed to, by and between the parties;

1. Respondent admits to the jurisdiction of the Board and agrees to remain under the jurisdiction of the Board;
2. Respondent voluntarily surrenders her license/privileges to practice dentistry in the State of Rhode Island;

3. Respondent may petition for reinstatement of her RI Dental License/privileges upon meeting all the terms of her agreement with the Massachusetts Board of Registration in Dentistry and reinstatement of her Massachusetts dental license;
