Summary Suspension

The Rhode Island Department of Health, Board of Medical Licensure and Discipline, received complaints that alleged that Andrew C. Stone, M.D. exposed himself and touched himself inappropriately in front of young boys in the Seekonk, Massachusetts YMCA. The Board conducted a review of the evidence provided by the Seekonk, MA and Barrington, RI police departments. The Board has determined that this is not the first incident of this nature and has referred the matter to the Director of Health for further consideration.


FINDINGS OF FACT

1. Andrew Cowley Stone, M.D, is a 1999 graduate of the University of Vermont Medical School. He completed post-graduate training under Brown University 's program in the Division of Pulmonary and Critical Care at the Rhode Island Hospital. He was born on 11/23/70 in Rochester, NY.
2. He had admitting privileges at the Roger Williams Hospital, Rhode Island Hospital and worked at the Veterans Administration Hospital.

3. The Rhode Island Hospital suspended his admitting privileges as of December 21, 2006 pending completion of an ongoing criminal investigation.
4. Dr. Stone was arrested and arraigned in Sixth Division District Court in Providence, Rhode Island for the purpose of extraditing him to Massachusetts to face four counts of Open and Gross Lewdness filed by Seekonk Massachusetts police.

ORDER

After considering the evidence of open and gross lewdness filed by the Seekonk, Massachusetts Police Department and evidence indicating that there was prior behavior of a similar nature, the Director of Health has determined that the continued practice of Andrew C. Stone, M.D. would constitute an immediate danger to the public. Accordingly, the license to practice medicine in the State of Rhode Island issued to Andrew C. Stone, M.D. is hereby SUSPENDED. The licensee has the right to an administrative hearing on this suspension within 10 days of this Order pursuant to R.I.G.L. § 5-37-8.


