AMENDED CONSENT ORDER

Gayle Rebovich, M.D. (hereafter "Respondent") has applied to the Board of Medical Licensure and Discipline (hereinafter the "Board") to modify the previously ratified Consent Order of May 13, 2015 to remove a term of probation which ran concurrent with a probation term in another state. The Board makes the following:

FINDINGS OF FACT

1. Respondent was issued her Rhode Island physician license on May 13, 2015. She graduated from Princeton University in 1998 and received her medical degree from Columbia University College of Physicians and Surgeons in 2005. Her specialty is neurology.
2. The Board entered into a Consent Order with the Respondent on May 13, 2015 in which she was granted a license with a Reprimand and a fine based on disciplinary action of another jurisdiction. She was also to serve a reciprocal probation term in Rhode Island consistent with that of the other jurisdiction, following ratification of the proposed order of the Board of the other jurisdiction and to provide quarterly reports. The Respondent was able to petition the Board to waive the requirement of probation and/or monitoring to be allowed solely at the discretion of the Board.

3. Respondent has met the requirements of the Consent Order and petitioned the Board for early termination of the probation imposed in the May 13, 2015 Consent Order.
4. The Board agrees to the early termination of the probation and its requirements.

Based on the foregoing, the parties agree as follows:

1. Respondent admits to the jurisdiction of the Board;
2. Respondent has reviewed this Amended Consent Order and understands that it is subject to final approval of the Board;
3. This Amended Consent Order is not binding on Respondent until final ratification by the Board;
4. If ratified by the Board, Respondent hereby acknowledges and waives:
 - a. The right to appear personally or by counsel or both before the Board;
 - b. The right to produce witnesses and evidence on his behalf at a hearing;
 - c. The right to cross examine witnesses;
 - d. The right to have subpoenas issued by the Board;
 - e. The right to further procedural steps except for those specifically contained herein;
 - f. Any and all rights of appeal of this Amended Consent Order; and
 - g. Any objection to the fact that this Amended Consent Order will be presented to the Board for consideration and review.
5. Respondent is hereby granted an unrestricted license as a physician in Rhode Island contemporaneously with the ratification of this Amended Consent Order.
6. Upon ratification of this Amended Consent Order the probation imposed in the May 13, 2015 Consent Order shall terminate.

7. This Amended Consent Order shall become part of the public record once it has been ratified by the board.
8. The findings and terms of the May 13, 2015 Consent Order shall remain in effect to the extent not inconsistent with this Amended Consent Order.
9. In the event that any conditions of this Amended Consent Order are violated after it is ratified, the Director of the Department of Health shall have the discretion to impose further disciplinary action, including summarily suspending the Respondent's license to practice medicine in the State of Rhode Island. If the Director suspends such license, Respondent shall be given notice and shall have the right to request an administrative hearing within ten (10) days of the suspension. The Director of the Department of Health shall also have the discretion to request an administrative hearing after notice to Respondent of any violation of this Consent Order. The Administrative Hearing Officer may suspend Respondent's license for the remainder of Respondent's probationary period if the alleged violation is proven by a preponderance of evidence.
