**CONSENT ORDER**

Oksun Edoro, M.D. is licensed as a physician in Rhode Island. After a review of the above-referenced complaint and accompanying medical records by an investigative committee ("Committee") of the Board of Medical Licensure and Discipline ("Board"), the Director of the Department of Health makes the following:

**FINDINGS OF FACT**

1. Oksun Edoro, M.D. ("Respondent") has been a licensed physician since August, 2005. He practices integrative medicine in Coventry, Rhode Island. He is Board Certified in Internal Medicine, Occupational Medicine and Environmental Medicine. He holds an MPH (Masters in Public Health) and an MBA in Health Care Management.
2. The Committee found that Respondents' medical records lacked adequate detail and history in a single medical record system.

3. The Committee also found Respondent's electronic medical record system to be insufficient and that he failed to always record and document reasons for certain prescriptions and his discussions with patients regarding treatment plans.
4. Based on the foregoing, Respondent is in civil violation of Rhode Island Rules and Regulations for Licensure and Discipline of Physicians § 11.4 for failure to create medical records that are consistent with the minimum standard.

**Based on the foregoing, the parties agree as follows:**


1. Respondent admits to the jurisdiction of the Board.
2. Respondent has reviewed this Consent Order and understands that it is subject to final approval of the Board; and this Consent Order is not binding on Respondent until final ratification by the Board.
3. If ratified by the Board, Respondent hereby acknowledges and waives:
  - a. The right to appear personally or by counsel or both before the Board;
  - b. The right to produce witnesses and evidence on his behalf at a hearing;
  - c. The right to cross-examine witnesses;
  - d. The right to have subpoenas issued by the Board;
  - e. The right to further procedural steps except for those specifically contained herein;
  - f. Any and all rights of appeal of this Consent Order; and

- g. Any objection to the fact that this Consent Order will be presented to the Board for consideration and review.
4. Respondent hereby agrees to a Reprimand based on the facts referenced above.
5. Respondent agrees to register for and attend a CPEP Seminar on Patient Care Documentation (recordkeeping), as well as a CPEP Personalized Implementation Program, which includes medical chart reviews over a six-month period.
6. Respondent agrees to include patients' medical, family, social and occupational history and shall document all <sup>DRE or</sup> GU/GRE exams in the patients' medical records.
7. Respondent agrees to pay an administrative fee to the Board for costs associated with investigating this complaint. Respondent shall submit to the Board within sixty (60) days a check made payable to the Rhode Island General Treasury in the amount of \$2400.00.
8. In the event that any conditions of this Consent Order are violated after it is ratified, Respondent shall be subject to further disciplinary sanctions.
