CONSENT ORDER

Steven McCloy, M.D. (hereinafter "Respondent") is licensed as a physician in Rhode Island. The Board of Medical Licensure and Discipline (hereinafter the "Board") found after the investigative committee's review of the complaint and the Respondent's written reply to the complaint that Respondent committed acts of unprofessional conduct. The Board further makes the following:

FINDINGS OF FACT

1. Respondent is a physician who has been licensed in Rhode Island since April 20, 1977. His business address is Axiom Occupational Health, 100 Smithfield Avenue, Pawtucket, Rhode Island. He graduated from Baylor College of Medicine on June 1, 1970.
2. A complaint was filed with the Board by another Rhode Island licensed physician who assumed the care of a patient who had been under the care of respondent for the past eight years.
3. In a case reviewed by the investigative committee, Respondent failed to document

to minimum standards for prescribing controlled substances by not including vital signs or physical examination as appropriate. Based on the foregoing, Respondent has violated Rhode Island General Laws §5-37-5.1(19) for failure to meet minimum standards of care regarding inclusion of vital signs and physical examinations in patient medical records.

Based on the foregoing, the parties agree as follows:

1. Respondent admits to the jurisdiction of the Board.
2. Respondent has agreed to this Consent Order and understands that it is subject to final approval of the Board, and this Consent Order is not binding on Respondent until final ratification by the Board.
3. If ratified by the Board, Respondent hereby acknowledges and waives:
 - a. The right to appear personally or by counsel or both before the Board;
 - b. The right to produce witnesses and evidence on his behalf at a hearing;
 - c. The right to cross examine witnesses;
 - d. The right to have subpoenas issued by the Board;
 - e. The right to further procedural steps except for those specifically contained herein;
 - f. Any and all rights of appeal of this Consent Order; and
 - g. Any objection to the fact that this Consent Order will be presented to the Board for consideration and review.


4. Respondent agrees to pay within sixty (60) days of the ratification of this Consent Order an administrative fee to the Board with a check for \$600 dollars made payable to the Rhode Island General Treasurer for costs associated with investigating the above-referenced complaint.
5. Based on the findings of fact in paragraph three in the preceding section, Respondent agrees to enroll in a Board-approved course in medical records within six months of ratification of this Order, and shall complete such course and provide results to the Board.
6. Based on the findings of fact in paragraph three in the preceding section, if Respondent continues to prescribe controlled substances, he agrees to enroll in the Vanderbilt University narcotic prescribing course within six months of ratification of this Order, and shall complete such course and provide results to the Board.
7. Respondent hereby agrees to this reprimand on his physician license.
8. In the event that any term of this Consent Order is violated, after signed and accepted, the Director of the Department of Health shall have the discretion to summarily suspend the Respondent's license and/or impose further disciplinary action. If the Director suspends the license and/or imposes further disciplinary action, Respondent shall be given notice and shall have the right to request an administrative hearing within twenty (20) days of the suspension and/or further discipline. The Director of the Department of Health shall also have the discretion to request an administrative hearing after notice to Respondent of a violation of any term of this Consent Order. The Administrative Hearing Officer




may suspend Respondent's license, or impose further discipline, if the alleged violation is proven by a preponderance of evidence.
