VOLUNTARY SURRENDER OF LICENSE

Voluntary Surrender of License

Taghi Rajabiun, M.D. (hereinafter "Respondent") is licensed as a physician in Rhode Island.

FINDINGS OF FACT

1. Taghi Rajabiun, M.D. (hereinafter "Respondent") has been a licensed physician in Rhode Island since December 18th, 1968. His practice is located in North Providence, Rhode Island. He is a 1959 graduate of University of Tehran. Respondent's specialty is cardiothoracic surgery.
2. The Board of Medical Licensure & Discipline (Board) has received two complaints regarding respondent.
3. Respondent surrendered his license 10.31.2016 while investigation into these matters was ongoing.
4. Respondent does not admit wrongdoing and the Board chooses to no longer contest the matter since Respondent has surrendered his license.

Based on the foregoing, the parties agree as follows:

1. Respondent admits to the jurisdiction of the Board.
2. Respondent has reviewed this Voluntary Agreement and understands that it is subject to final approval of the Director; and this Voluntary Agreement is not binding on Respondent until final ratification by the Director.
3. If ratified by the Board, Respondent hereby acknowledges and waives:
 - a. The right to appear personally or by counsel or both before the Board;
 - b. The right to produce witnesses and evidence on his behalf at a hearing;
 - c. The right to cross-examine witnesses;
 - d. The right to have subpoenas issued by the Board;
 - e. The right to further procedural steps except for those specifically contained herein;
 - f. Any and all rights of appeal of this Voluntary Agreement;
 - g. Any objection to the fact that this Voluntary Agreement will be presented to the Board for consideration and review.
 - h. Any objection that this order, once ratified will be reported to the National Practitioner Data Bank, the Federation of State Medical Boards and posted on the Rhode Island Department of Health web site.
5. Respondent shall not seek reactivation of this physician license without satisfying specific CME requirements of the Board to assure competency consistent with the standards of this profession.

6. Respondent agrees to pay an administrative fee to the Board for costs associated with investigating this complaint. Respondent shall submit to the Board within sixty (60) days a check made payable to the Rhode Island General Treasury for the amount of \$1300.00.
7. In the event that any conditions of this Consent Order are violated after it is ratified, the Director of the Department of Health shall have the discretion to impose disciplinary action, including summarily suspending the Respondent's license to practice medicine in the State of Rhode Island. If the Director suspends such license, Respondent shall be given notice and shall have the right to request an administrative hearing within ten (10) days of the suspension. The Director of the Department of Health shall also have the discretion to request an administrative hearing after notice to Respondent of any violation of this Consent Order.
