

CONSENT ORDER

Pursuant to Section 5-34-24 the General Laws of the State of Rhode Island, 2008 Reenactment, a complaint was filed with the Board of Nurse Registration and Nursing Education (hereinafter referred to as "Board") charging David Woods, RN, Respondent with a violation of Chapter 5-34 of the General Laws of the State of Rhode Island, 2008 Reenactment.

After consideration by the Investigating Committee of the Board, it was agreed by and between the parties:


1. Respondent is a registered nurse licensed to practice in the State of Rhode Island.
2. That at all pertinent times Respondent was employed at Charlesgate Nursing Center, Providence, Rhode Island.
3. That Respondent failed to maintain the standards of nursing practice by utilizing a patient's permacath to infuse normal saline. The Dialysis Center reports that the order from the physician at the Center notes that this line is not to be used for any IV use, this order is in the patient's record.
4. There is a previous complaint in regard this nurse, he is reported to have been working with an expired nursing license for more that a year. He is noted to have been reprimanded by the BON in 2004. Query of the Adult Criminal Data Base indicates positive findings for previous criminal charges. Review of nurse's personnel file notes previous disciplinary actions in regard to issues relating to his nursing practice.


5. That the conduct described in paragraph three (3) herein constitutes unprofessional conduct as defined in Section 5-34-24 (6) (iv) (v) and the Rules and Regulations promulgated there under.

The parties agree as follows:

1. Respondent is a registered nurse, license number RN25530 and able to conduct business under and by virtue of the laws of the State of Rhode Island.
2. Respondent admits to the jurisdiction of the Board.
3. Respondent has read this Consent Order and understands that it is a proposal of the Board and subject to final ratification by the Board. This Consent Order and the contents thereof are not binding on Respondent until final ratification by the Board.
4. Respondent hereby acknowledges and waives:
 - a) The right to appear personally or by counsel or both before the Board;
 - b) The right to produce witnesses and evidence in his behalf at a hearing;
 - c) The right to cross-examine witnesses;
 - d) The right to have subpoenas issued by the Board;
 - e) The right to further procedural steps except for those specifically contained herein;
 - f) Any and all rights of appeal of this Consent Order;
 - g) Any objection to the fact that this Consent Order will be presented to the Board for consideration and review;
 - h) Any objection to the fact that it will be necessary for the board to become acquainted with all evidence pertaining to this matter in order to adequately review this Consent Order;

- i) Any objection to the fact the Board reviewing this Consent Order may be the same as the Hearing Committee presiding over this matter should it later be brought to an administrative proceeding;
- j) Any objection to the fact that potential bias against the Respondent may occur as a result of the presentation of this Consent Order to the Board. The signing of this Consent Order is for settlement purposes only.
6. This Consent Order shall become part of the public record of this proceeding once it is accepted by all parties and accepted by the Board.
7. Acceptance by the Respondent and approval by the Board of this Consent Order constitutes an admission of the facts contained herein.
8. Respondent voluntarily agrees to accept the sanction of a Reprimand and continuing education.
9. That the Respondent shall, on or before March 22, 2013, present evidence of enrollment and satisfactory completion of continuing education courses in "Documentation: A Critical Aspect of Client Care, Medication Errors Detection and Prevention, and Ethics of Nursing Practice." 10. That should Respondent fail to comply with the laws and regulations governing the practice of nursing and/or fail to comply with the terms of this Consent Order, his license as a registered nurse shall be subjected to suspension or other appropriate disciplinary action.
