Unfortunately, there is a lot of misinformation about fluoridation on the internet. This presentation will help the dental community strategize on how to effectively counter fluoridation misinformation and improve the knowledge and attitudes of their communities and patients.

This presentation will explain how silver diamine fluoride treats dental caries and its potential use in various dental settings, including with elderly populations. Attendees will learn how to integrate this treatment modality into their dental practice.

1:30 Comparing Caries Risk Assessment Tools Yara Halasa-Rappel, DMD, PhD

Caries risk assessment (CRA) tools can address oral health disparities and improve the efficiency of the oral health care system. A valid, evidence-based, reliable, and accurate CRA tool could help identify people at high and moderate risk of developing dental caries and justify the reallocation of resources from people at low risk to those at moderate and high risk by reducing redundancy of services for those at low risk. In this session, Dr. Halasa-Rappel describes her research exploring the feasibility of using available CRA tools in informing oral health care strategies and policies.

2:30 Preventing Childhood Obesity: Oral Health's Role Alison Tovar, PhD, MPH Kate Balestracci, PhD, RD

This workshop will identify the role oral health practitioners can play in preventing childhood obesity. Dr. Tovar and Dr. Balestracci will discuss childhood obesity trends, including causes and possible solutions. Participants will review case studies and identify effective parent engagement strategies.

3:45 A Tooth-Friendly Approach to Clinical Caries Evaluation Laurence LoPresti, DMD Irina Smilyanski, RDH, MS, MSDH

Many entities currently search for a more prevention-focused way to evaluate clinical caries. One new approach is the International Clinical Caries Management System (ICCMS), developed by the International Caries Detection and Assessment System (ICDAS) Foundation. This system aligns contemporary understanding of the caries formation process with a preventive approach to oral health. This presentation will assist dental professionals in understanding the new system and provide suggestions on clinical utilization of ICCMS.
